

However, most of the time injured victims or families of those who have passed away face huge challenges when processing a claim with the RAF.

Accident Protect provides these victims of car accidents with immediate access to an effective RAF claims management system and 100% of the recovery paid back to them.



MORE ABOUT BAIL PROTECT

With the police now able to arrest anyone with outstanding traffic fines or traffic offences, the number of people in South Africa who can be arrested and be granted bail for relatively minor traffic offences are increasing. Added to this, the reported cases of unlawful arrest and arrests using unnecessary force are also increasing.

Bail Protect is an innovative service providing assistance in posting bail following an arrest for a minor crime. This service assists in exercising your legal rights and ensures that you don't have to spend unnecessary time behind bars.

TERMS & CONDITIONS

POTHOLE PROTECT

- Service is limited to irreparable tyre damage as a result of a pothole on a road within the borders of the Republic of South Africa.
- Pothole Protect will help only in respect of vehicles owned by you and your spouse.
- No service will be provided:

 a. if you have already claimed or are in the process of claiming for the damage from your Insurance Company;
 - b. if the incident is not reported to us within 5 (five) working days of the incident.
- Where the assessor does not substantiate the merits of the case, if you do not agree, or there is material conflict between your assessment and that of the assessor, then the case will be referred to the Pothole Protect Advisory Panel. The decision of the Pothole Protect Advisory Panel will be final and binding on all the parties. The Pothole Protect Advisory Panel will consist of an admitted attorney as well as a tyre expert from a leading tyre retailer. Pothole Protect will not be responsible for any costs incurred in referring your case to the Panel.
- You are at all times free to get outside second opinions but the costs of these will not be borne by Pothole Protect, unless same have been prior approved in writing.

- Your membership must be fully paid up at the time of the incident.
- At the time of the incident you must have complied with all the legal and regulatory requirements of the Roads Acts of South Africa and other such relevant legislation.
- Pothole Protect does not guarantee recovery from the relevant roads agency.

FINES PROTECT

- Fines are said to be "issued" once they are posted onto www.paycity.co.za
- Fines Protect can only check and notify you of fines that are posted onto www.paycity.co.za
- Other fines that are not posted onto www.paycity.co.za can be dealt with by Fines Protect, but Fines Protect must be notified of these by you before Fines Protect service can commence.
- The full discount/recovery amount will be passed back to you.
- Fines Protect service is limited to traffic fines issued within the Republic of South Africa.
- Fines Protect service is limited to you, the main member.

- At the time of the fine you must have complied with all the legal and regulatory requirements of the Roads Acts of South Africa and other such relevant legislation.
- Fines Protect does not guarantee the performance of the traffic department.
- Fines Protect service does not include AARTO de-merit points reductions.
- Guaranteed discounts will only be available for fines received after date of inception of the membership.
- Your membership must be fully paid up at the time of the incident.
- Traffic fine discounts will only be valid for 15 days from date of invoice, unless held for longer by the relevant traffic department.
- Fines Protect cannot be held liable for penalty fees applied on AART fines in the event of a negative outcome on representation.

LICENCE PROTECT

- Licence Protect service is limited to licence renewals within the Republic of South Africa.
- Licence Protect service is limited to the main member.

- Your membership must be fully paid up at the time of the licence renewals and delivery.
- Licence Protect will attempt to make the initial licence delivery to the member, but if the delivery cannot be fulfilled due to the member, then any subsequent delivery will be for the member's own cost.
- At the time of the licence renewal you must comply with all the legal and regulatory requirements of the Roads Acts of South Africa and other such relevant legislation.
- Licence Protect does not guarantee the performance of the licence department and/or Post Offices.
- Licence Protect invoices will only be valid for 15 days.
- Licence Protect cannot be held liable for any delays in payment or response by the member.
- Due to the personal nature of the information, Licence Protect cannot assist in making changes to member's details on e-natis.
- Pro-active notifications on new fines is dependent on member providing the correct vehicle registration number, at least 45 days prior to expiry date.
- Licence Protect cannot be held responsible for processing costs or refunds where incorrect vehicle registration number was provided by the member.

ACCIDENT PROTECT

- We will limit our services where our legal practitioner does not substantiate the merits of the case. If this is in conflict with your view or there is a material conflict between your assessment and our legal practitioner's assessment, the case will be referred to the Accident Protect Advisory Panel (which will consist of the Accident Protect legal advisor as well as 2 external independent legal advisors) for review. The costs of this review process will be for your own account.
- You are at all times free to get outside second opinions but the cost of these will not be borne by Accident Protect unless approved in writing.
- You are not obliged to use the services of Accident Protect in the event of which Accident Protect will not be liable for any costs incurred by these parties.
- The Accident Protect service is only available for accidents that occur in the RSA
- You must be fully paid-up and eligible for its services at the time of the motor accident.
- At the time of the accident you must have complied with all the legal and regulatory matters required by the Acts governing the Road Accident Fund (RAF).
- Accident Protect does not guarantee performance from the RAF.

BAIL PROTECT

No bail assistance will be provided where:

- The amount of bail exceeds R 3.000.
- The crime of which you are accused is classified as one of:
 - Assault with Grievous Bodily Harm
- Murder or Attempted murder
- Rape
- Child abuse
- Child pornography
- Dealing in drugs
- Armed robbery or robbery with aggravating circumstances
- Treason, sabotage or subversion
- The crime of which you are accused is classified as one contemplated in Part II or Part III of Schedule 2 of the Criminal Procedure Act, 51 of 1977.
- The Issuing Authority is outside the Republic of South Africa.
- The Issuing Authority is anyone other than an authorized police official as contemplated in Section 59 of the Criminal Procedure Act, 51 of 1977.
- The fees due have not been paid and accepted by the Administrator.
- A claim has previously been paid under this Agreement where you did not supply the Administrator with the receipt for the bail within 24 hours of the payment being lodged with the Issuing Authority and/or where you did not appear in court as per the bail conditions.
